Additionally, the Hon'ble Vice Chancellor has also desired to complete the formation of nomination-based Students representation in Students Central Association in the Sardar Patel University Campus up to 29-10-2022.

The nomination for departmental/class representatives should be recommended by the Principal/Chairperson/Head of the concerned teaching departments in accordance with the provision contained in Lyngdoh committee recommendations. The nomination forms duly recommended by the Principal/Chairperson/Head of the department/institution should reach in the office of the undersigned on or before 27-10-2022 up to 5:00pm positively. The whole process of nomination-based formation of the SCA should be completed before 29-10-2022. The specimen Performa of nomination form are also attached with the notification.

The cutoff date for the determination of the age of the nomination-based representation in the SCA will be as under.


